SUBJECT: 2020 Bulletproof Vest Partnership Grant Award

Background

In April 2020, the South Fulton Police Department applied for the Department of Justice 2020 Bulletproof Vest Partnership Grant to obtain funding to offset the cost of purchasing new bulletproof vest and replacing expired and damaged vests for sworn officers. The grant award will fund 50% of the cost to purchase 27 new vests.

Total project amount: \$22,869 Total Federal award amount: \$11,434.50 Total City obligation amount: \$11,434.50

The South Fulton Police Department will fund the City's obligation from the Police uniform funding line (100-3210-53-1591).

Awards will not be extended past that date, and any unused funds will be forfeited.
